Dear Mr. Kaechele,

I am sorry you didn't manage to get visa from the Embassy (shame on bureaucrats of all nations!).

Yes, I confirm you can get visas at the border! Many people have done and you will do. Please see attached Armenian visa application form for your reference. You can have it filled out on your arrival or alternatively get one at the border. Simple visitor visas are issued at the border with the shortest period of validity of 21 days. The fee is Armenian Dram 3,000, which is approximately USD 8. I have found a driver who regularly takes people from here to Tbilisi and vice versa.

We will pay him here. He will drive to Tbilisi on Apr 12 and will return to Yerevan on Apr 13 with you, so you don't have to pay for taxi at all. Additionally I will provide the driver with 2 invitation letters for you and your spouse from Armenian Psychoanalytical Association which you will present at border along with the application forms. I will state our phone numbers in the invitations so that the Officers can contact us just in case. Could you please provide you wife's name and surname? I do not believe it is going to be a complicated procedure, I know for sure that visas are regularly and easily issued for foreigners crossing border from Georgia. For comparison, example and illustration: issuing visa at the airport (which is just another border) takes literally 5 minutes! It should be a very similar procedure at any border. It takes 4-5 hours to drive to Yerevan form Tbilisi, so it would be great if you depart from Tbilisi in the morning to be in Yerevan early afternoon.

The driver's name is Volodya, he is driving a comfortable Mercedes, number 535 OOC. I have already provided Khatuna with his Georgian cell phone number and will pass him Khatuna's cell and home numbers.
